As one of the nation's largest builders, Balfour Beatty must balance speed, scale, and risk across hundreds of complex projects. For Jeff Brannen, Chief Legal Officer-Texas/Arizona, that means ensuring contracts are understood, risks are managed, and project teams can operate with confidence, all without stretching his time and limited legal resources. To meet these demands, his division adopted Document Crunch to streamline contract review, empower teams, and create consistency across projects.



#### The Challenge

Rapid growth and increasing contract complexity exposed needs in Balfour Beatty's legacy processes:

- Contracts required days of manual review, often by personnel without deep legal expertise, or by highly trained legal staff who had limited time.
- Claims and disputes threatened margins and outcomes.
- Training new managers was slow and heavily dependent on experts' time.

## CONTRACT REVIEW EFFICIENCY & KNOWLEDGE TRANSFER

- 50% reduction in review time cut from a full day or more to half a day

- Built-in training accelerates project manager development and reduces reliance on legal counsel's time.
