## BEFORE

### Document Crunch + Procore

Historically, Commodore Builders' project teams were required to complete manual contract checklists for every new project to aid and understand owner negotiations. The checklist and contract served as reference documents throughout the project, but accessibility, length, and team workload made it unlikely that these documents would get used. When questions over contract terms surfaced, project managers waited for clarification from general counsel. 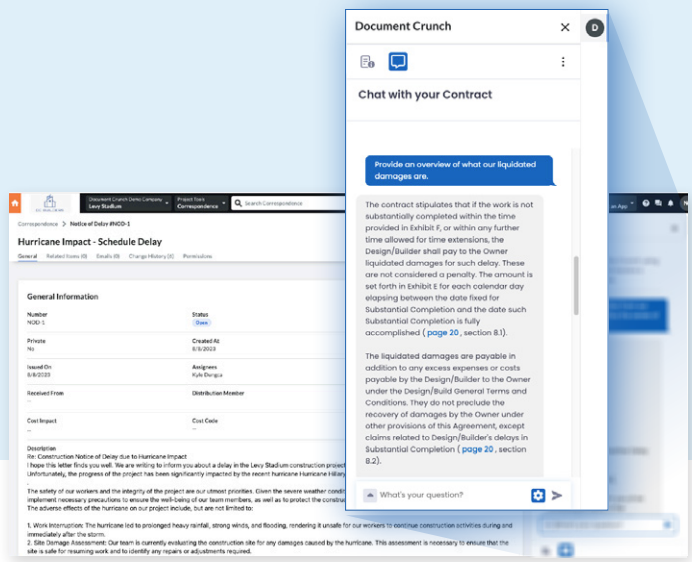
